

ORDINANCE NO. 2009-057

AMENDING ORDINANCE NO. 2007-071 ENACTED ON SEPTEMBER 19, 2007, WHICH AUTHORIZED THE ISSUANCE AND SALE OF NOT EXCEEDING \$12,135,000 GENERAL OBLIGATION BONDS, SERIES 2007, OF THE CITY OF COLUMBIA, SOUTH CAROLINA; DELETING CERTAIN PROJECTS AND INCLUDE ADDITIONAL PROJECTS FOR WHICH THE BONDS MAY BE ISSUED; AND OTHER MATTERS RELATING THERETO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, SOUTH CAROLINA, AS FOLLOWS:

SECTION 1. The City Council (the "Council") of the City of Columbia, South Carolina (the "City") hereby finds and determines:

(a) On September 19, 2007, the Council enacted Ordinance No. 2007-071 (the "Bond Ordinance") which authorized the issuance and sale of not exceeding \$12,135,000 General Obligation Bonds (the "Bonds") of the City. The Bonds were issued in two series, to wit: \$9,085,000 original principal amount General Obligation Bonds, Series 2007A, dated December 11, 2007 (the "Series 2007A Bonds") and \$3,050,000 original principal amount General Obligation Bond, Series 2007B, dated December 11, 2007. Terms not otherwise defined herein shall have the meanings assigned to them in the Bond Ordinance.


(b) The Council desires to delete certain projects as set forth in Section 2(f) of the Bond Ordinance and include additional projects for which the proceeds of the Series 2007A Bonds may be expended as set forth in Section 2 of this Ordinance.

SECTION 2. Section 2(f) of the Bond Ordinance is hereby amended to delete the following projects: Item (i) "constructing and equipping a new fire station on Broad River Road" and Item (iv) "constructing and equipping an ambulatory center at the City's animal shelter" each shall be deleted. Section 2(f) is hereby amended to include the following projects as additional items: (viii) Washington Square elevator up-grade; and (ix) constructing, furnishing and equipping a Park and Recreation Administration Building.

SECTION 3. This Ordinance shall forthwith be codified in the Code of City Ordinances in the manner prescribed by law. The provisions of this Ordinance shall be effective upon its enactment.


