


RE: **STAFF RECOMMENDATION for

1701 MAIN STREET, MIDBLOCK PAD.**

Robert Spencer operated at the northwest corner of Main Street and Gervais Street during 2003, and he moved to the 1701 Main Street midblock pad during 2004. Mr. Spencer would continue to operate in the same manner as he had for the previous year, which is the same as he did at Main and Gervais Streets. A copy of the 2003 application is attached for your information. To the best of our knowledge, the City received no complaints about his operation at 1701 Main Street or about his previous operation at Main and Gervais Streets. **Staff recommends approval, subject to review and approval of evidence of insurance and of compliance with health and fire codes (§11-257).**
