

RESOLUTION NO.: R-2001-021

Authorizing Sidewalk Sale for Merchants
on Saluda Avenue between Devine Street and Greene Street

WHEREAS, the merchants in the block of Saluda Avenue between Devine Street and Greene Street (the Merchants) are sponsoring a Sidewalk Sale for merchants in the block of Saluda Avenue between Devine Street and Greene Street on Saturday, April 14, 2001 and Saturday, May 12, 2001; and,

WHEREAS, the Merchants have requested permission to conduct sidewalk sales as part of the celebration; and,

WHEREAS, it has been determined that such an event would be in the public interest;

NOW, THEREFORE,

BE IT RESOLVED by the Mayor and City Council of the City of Columbia, South Carolina, this 28th day of March, 2001, that between the hours of 10:00 a.m. and 2:00 p.m. on Saturday, April 14, 2001 and Saturday May 12, 2001, merchants in the block of Saluda Avenue between Devine Street and Greene Street are authorized to operate sale booths for items normally sold in their course of business as well as food and beverages items, except alcoholic beverages, beer and wine, on the sidewalks immediately in front of their places of business; and,

BE IT FURTHER RESOLVED that all vendors be restricted to stationary location; and,

BE IT FURTHER RESOLVED that only pedestrian traffic will be allowed within the area.

All other traffic, including, but not limited to, automobiles, trucks, motorcycles, mopeds,

bicycles, skate boards, and horses, except police horses, is prohibited. All pets shall be prohibited. Coolers, glass bottles and breakable glasses and/or cups shall be prohibited; and,

PROVIDED, HOWEVER, that sidewalks shall not be obstructed for pedestrian traffic in violation of Sec. 14-32, 1998 Code of Ordinances of the City of Columbia, South Carolina. and that no vendor locations be allowed on any street during the period of the celebration.






