WHEREAS, the Merchants have requested permission to conduct sidewalk sales as part
of the celebration; and,

WHEREAS, it has been determined that such an event would be in the public interest;

NOW, THEREFORE,

BE IT RESOLVED by the Mayor and Council this 10th day of October, 2001, that
between the hours of 7:00 a.m. and 3:00 p.m. on Saturday, October 20, 2001, merchants in
the areas designated above are authorized to operate sale booths for items normally sold in their
course of business as well as food and beverages items, except alcoholic beverages, beer and
wine, on the sidewalks immediately in front of their places of business; and,

BE IT FURTHER RESOLVED that all vendors be restricted to stationary location; and,

BE IT FURTHER RESOLVED that only pedestrian traffic will be allowed within the area.
All other traffic, including, but not limited to, automobiles, trucks, motorcycles, mopeds,
bicycles, skate boards, and horses, except police horses, is prohibited. All pets shall be

prohibited. Coolers, glass bottles and breakable glasses and/or cups shall be prohibited; and,
PROVIDED, HOWEVER, that sidewalks shall not be obstructed for pedestrian traffic in
violation of Sec. 14-32, 1998 Code of Ordinances of the City of Columbia, South Carolina. and
that no vendor locations be allowed on any street during the period of the celebration.
