

**RESOLUTION NO.: R-2002-007**

Authorizing Sidewalk Sales for Granger Owings, Inc.  
at 1333 Main Street

WHEREAS, Granger Owings, Inc. ("Owings") desires to hold sidewalk sales during their normal business hours of 9:00 a.m. to 6:00 p.m. on Wednesday, February 20, 2002; Thursday, February 21, 2002; Friday, February 22, 2002 and Saturday, February 23, 2002, on the sidewalk immediately adjacent to its store located at 1333 Main Street; and,

WHEREAS, it has been determined that such sales would be in the public interest;  
NOW, THEREFORE,

BE IT RESOLVED by the Mayor and Council this 13th day of February, 2002, that during the normal business hours of 9:00 a.m. to 6:00 p.m. on Wednesday, February 20, 2002; Thursday, February 21, 2002; Friday, February 22, 2002 and Saturday, February 23, 2002, Granger Owings is authorized to hold sidewalk sales for items normally sold in its course of business, except alcoholic beverages, beer and wine, on the sidewalk immediately in front of its places of business located at 1333 Main Street; and,

BE IT FURTHER RESOLVED that all vendors be restricted to stationary location; and,

PROVIDED, HOWEVER, that sidewalks shall not be obstructed for pedestrian traffic in violation of Code Sec. 22-72, 1998 Code of Ordinances of the City of Columbia, South Carolina, and that no solicitation or transactions be made in violation of Code Sec. 14-32, 1998 Code of Ordinances of the City of Columbia, South Carolina, and that no vendor locations be allowed on any street during the period of the sidewalk sales.




