

) INTERGOVERNMENTAL AGREEMENT
COUNTY OF RICHLAND)

WHEREAS, the City of Columbia and the Town of Irmo have a common goal in beautifying the area at the intersection of Interstate 26 and Lake Murray Boulevard in Richland County, South Carolina, and a portion of which serves as an entrance to the Town of Irmo and;

WHEREAS, the Town of Irmo and City of Columbia wish to work together in the spirit of cooperation and;

WHEREAS the City of Columbia and the Town of Irmo believe that working together is in the best interests of the citizens, residents and taxpayers of their respective municipal entities.

BE IT NOW, THEREFORE, RESOLVED that:

This Agreement is made and entered into this _____ day of _____, 2003, between the City of Columbia, South Carolina, and the Town of Irmo, South Carolina.

This consideration for this Agreement is the mutual promises set forth herein.

This Agreement is intended to cover the intersection of Interstate 26 and Lake Murray Boulevard in Richland County, South Carolina.

The parties acknowledge that the intersection in question has four quadrants. The quadrants are immediately adjacent to the Interstate and Lake Murray Boulevard.

The parties agree that for the term of this Agreement, the City of Columbia shall provide water *at its own expense* for the purpose of irrigating and maintaining all four quadrants of the intersection in question. Additionally, for the term of this Agreement, the City of Columbia shall keep the grass cut on all four quadrants.

The Town of Irmo agrees that it will keep trash pick up maintained on all four quadrants. Irmo shall further maintain the plant life on the four quadrants and replace bushes as

reasonably necessary throughout the course of this Agreement.

This Agreement shall be for a period of four (4) years beginning with the date first written above. This Agreement shall continue for successive four (4) year periods unless either party terminates the Agreement by written notice at least thirty (30) days prior to the expiration of the then existing four (4) year term.

The Agreement set forth herein constitutes the entire Agreement of the parties.
