**Authorizing Art on the Weekends in Five Points**

WHEREAS, The Five Points Association (the Association) is sponsoring Art on the Weekends at the Five Points Plaza Fountain on Saturdays, September 10, 2005; October 1, 2005; November 5, 2005 and December 3, 2005; and,

WHEREAS, it has been determined that such an event would be in the public interest;

NOW, THEREFORE,

BE IT RESOLVED by the Mayor and Council this 14th day of September 2005, that between the hours of 12:00 p.m. and 5:00 p.m. on Saturdays, September 10, 2005; October 1, 2005; November 5, 2005 and December 3, 2005; artists are authorized to exhibit and sell their works with the exception of food and beverage items, alcoholic beverages, beer and wine; and,

BE IT FURTHER RESOLVED that all vendors are restricted to stationary location; and,

PROVIDED, HOWEVER, that sidewalks shall not be obstructed for pedestrian traffic in violation of Sec. 14-32, 1998 Code of Ordinances of the City of Columbia, South Carolina, and that no vendor locations be allowed on any street during the period of the event.



No concessions or beverages of any type will be sold at the events. All artists are responsible for collecting appropriate sales tax. No streets will need to be closed. The area for the exhibit and sale will be located surrounding the Five Points Plaza fountain, where tents will be set up. Artists will be required to park in Carolina First parking lot. In the event that artist response warrants additional set-up space, that space will be within Five Points on designated sidewalks out of the area of construction. The Five Points construction team has been notified of the dates and believe that no conflict will arise based on the current construction schedule.
